



Most Inspiring Scrutiny Newcomer Award 2018

This award recognises excellence in scrutiny practice that others can learn from and that will inspire future tenant scrutiny development in Scotland. It will reward the work of a newly formed group who have created an outstanding improvement or change to tenants and service users, the wider community and housing services.

Award description

The nominee will be a motivated and committed group of tenants and service users who have worked in partnership with a Registered Social Landlord or Local Authority to make an outstanding contribution towards influencing landlords' services and performance improvement.

Who is eligible?

- » Scrutiny Panels, Scrutiny Groups, Mystery Shopping Projects, Tenant Led Inspection Projects who have been established in the last 18 months
- » Tenants and/or Residents Organisations working in scrutiny
- » Community groups working in scrutiny

Who can make the nomination?

- » A member of the group
- » A support worker working with the group
- » A member of the housing organisation's staff
- » A member of the landlord's governing body
- » A member of the organisations staff
- » A local agency

How will the nomination be judged?

- » An independent judging panel will consider the nomination against the award criteria
- » Each question lists the award criteria
- » Make sure all questions are answered as fully as possible against the criteria
- » Keep your nomination concise and focused
- » Do not exceed the maximum word count
It is okay to use bullet points or lists
- » Include substantial evidence in your nomination submission
- » Submit supporting evidence if it helps to support your nomination submission

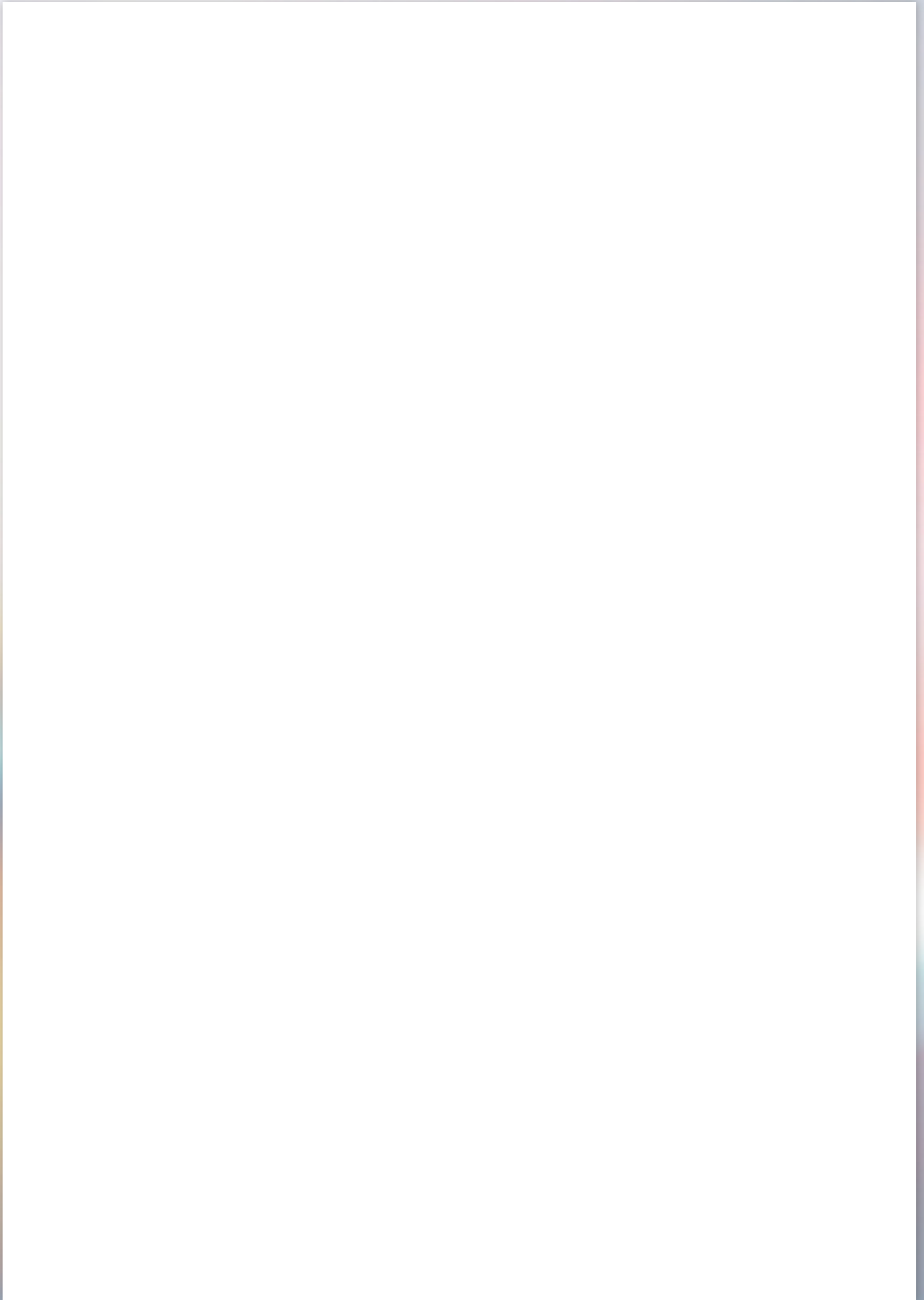
