



# Scrutiny Excellence Award 2018

This award recognises excellence in scrutiny practice from a housing organisation that others can learn from and that will inspire future tenant scrutiny in Scotland. It will reward exceptional tenant led scrutiny activities which have created an outstanding improvement or change to individuals, the wider community, the housing organisation and housing services.

## *Award description*

The nominee will be an innovative and forward thinking housing organisation who has made an outstanding contribution towards tenants and other service users participating in and influencing housing services, performance improvement and ensuring that tenant scrutiny is embedded within the strategic direction of the organisation.

## *Who is eligible?*

- » Registered Social Landlords (RSL)
- » Local Authorities
- » Third sector/ Voluntary and Charitable Organisations

## *Who can make the nomination?*

- » A member of the Local Authority or RSL staff
- » A member from the housing organisation's Governing Body
- » An member of staff from the Third sector/ Voluntary and Charitable Organisation
- » A local agency

## *How will the nomination be judged?*

- » An independent judging panel will consider the nomination against the award criteria
- » Each question lists the award criteria
- » Make sure all questions are answered as fully as possible against the criteria
- » Keep your nomination concise and focused
- » Do not exceed the maximum word count  
It is okay to use bullet points or lists
- » Include substantial evidence in your nomination submission
- » Submit supporting evidence if it helps to support your nomination submission




